

# 2019 Van Buren County Fair

## Checklist of requirements to show Animals

### All State Fair Livestock require additional entry by July 1<sup>st</sup>- Additional requirements for state fair

- Must be enrolled in 4h online by May 15 or Prior to Market Animal weigh in
- Animal ID in 4h online by May 15) (Exception-rabbit and poultry July 1<sup>st</sup> 4h online, Market Beef ID February 1<sup>st</sup>)
- Drug Affidavits complete for market animals
- Read your Fair book!!
- Entries Due in Fair Entry July 5
- Extra ultrasound fees (\$10) must be postmarked or at the extension office by July 5th
- A member must attend six (6) Van Buren County 4-H activities, three (3) of which must be club or county meetings, to exhibit at the Van Buren County Fair
- All animals are required to have a health certificate issued by Vet After July 1st

<p><b>Market Beef</b></p> <ul style="list-style-type: none"> <li>▪ December Weigh in</li> <li>▪ ID verify by February 1<sup>st</sup> in 4h online</li> <li>▪ YQCA Certification (by July 1<sup>st</sup>) Honor FSQA Test</li> </ul>	<p><b>Breeding Beef/Dairy Cattle</b></p> <ul style="list-style-type: none"> <li>▪ ID by May 15<sup>th</sup> in 4honline</li> <li>▪ YQCA Certification (by July 1<sup>st</sup>) Honor FSQA Test</li> <li>▪ Dairy Cattle FEMALES ONLY!</li> </ul>
<p><b>Horse</b></p> <ul style="list-style-type: none"> <li>▪ ID by May 15<sup>th</sup> in 4h online</li> <li>▪ Let CYC or Superintendent know if Hauling in/out or Stalling by July 11th</li> </ul>	<p><b>Cow/Calf Pair</b></p> <ul style="list-style-type: none"> <li>▪ ID AS A COW/CALF PAIR by May 15<sup>th</sup> 4honline</li> <li>▪ ID the cow as breeding beef by May 15<sup>th</sup> 4honline</li> <li>▪ ID the calf as breeding beef by May 15<sup>th</sup> 4h online</li> <li>▪ YQCA Certification (by July 1) Honor FSQA Test</li> </ul>
<p><b>Rabbit</b></p> <ul style="list-style-type: none"> <li>▪ ID by July 1<sup>st</sup> in 4h online</li> <li>▪ YQCA Certification (by July 1<sup>st</sup>) Honor FSQA Test</li> </ul>	<p><b>Dog/Cat/Pet</b></p> <ul style="list-style-type: none"> <li>▪ ID by May 15<sup>th</sup> in 4h online</li> <li>▪ Dogs and Cats: exhibitor must bring rabies certificate to show</li> </ul>
<p><b>Poultry</b></p> <ul style="list-style-type: none"> <li>▪ ID by July 1<sup>st</sup> in 4h online</li> <li>▪ YQCA Certification (by July 1<sup>st</sup>) Honor FSQA Test</li> </ul>	<p><b>Poultry</b></p> <p>Pullorum testing: Attend County one or bring certificate it was tested</p>
